

XIX Baltic Polonez Cup Race 2018
III Single & Double Handed Sailing Championship of Poland – Sailportal.pl Sailing Foundation
Date: 11 - 17 August 2018 – Szczecin and Swinoujście

DECLARATION OF PARTICIPANTS

1. ON THE EVENT START DAY: I am at least 18 years old, I am aware of the event's difficulty, there are no medical counter indications preventing me from participation in the event, I have sailing knowledge and skills, a seaworthy and safe yacht with all the required documents and equipment (for 24/h Single or Double sailing, inland waters in pre-start and Pomorska Bay in Świnoujście Cup)
2. Participants participate in race on their own risk and responsibility, take full responsibility for their participation and undertake to repair and cover all costs, including costs of rescue operations, compensation, etc.
3. The attention of participants is drawn rule 4 of part 1 ISAF RRS – Fundamental laws: Each Person in charge is individually solely responsible for decision to participate in race or continue racing, is personally responsible for his voyage, meeting the requirements of minimum yacht equipment, crew's entitlements, compliance with safety requirements according to applicable regulations and rules of good marine practice.
4. Organizer and Judge Committee do not supply any physical and online assistance during long race. In case of failures, life threats: participants have duty to act according to internationally recognized standards of conduct in case of saving lives at sea and calling help.
5. Participant may appoint his own coast team which will supply an individual online assistance based on satellite tracking, may also appoint his own assistance on water. It is recalled that, in accordance with the rules RRS a participant can not use any external help during race, neither use transmitted information which are not available to other participants. One can use such help after discontinuing the race.
6. The participant is obliged to inform about the possible resignation from the start as soon as possible
7. Sending a completed application is automatically consent to the terms of the application form and print statements
8. Print of application and statement will be signed by the participants before races during personal applications
9. Event materials - are entitled to the participants, who will compete in the event
10. Material prizes from partners and sponsors, are going to be draw among present participants on Ending ceremony in Świnoujście
11. Event can be held in any weather conditions, it will not be stopped (unless exceptional circumstances have arisen), and the event can be postponed or called off if it poses risks to safety.
12. I have needed equipment: appropriate for OSR category 3 (long race) and OSR category 4 (other)
13. I am familiar and will abide by the rules regarding: calling and giving help on sea, extreme caution during the Start, passing Christiansø archipelago and crossing the finish line in Świnoujście, and during the race on the Oder River in Szczecin (Prestart) and during races in Świnoujście Cup
14. I agree to berth in the Marina OSIR and North-East marina only in a place designated by the Organizer (Map berth)
15. I will be financially responsible for the Tracking device; will return it (undamaged) directly to the Organizer up to 16.08.2017 – failure to return the device incurs a fee equivalent to GBP 650
16. I undertake to abide by Fair Play sailing rules and in accordance with the principles identical to those of ISAF rules
17. Use of an auxiliary engine during the race is permitted only to battery charging in neutral gear, life and property rescue operations, entering/leaving the harbour to repair any malfunction – in such a situation, yacht must return to a position of starting the engine. In such cases, an entry in the log book should be made and give general message, available on channel 77 VHF, informing about charging, failure, life-saving or other
18. Use of external routing is prohibited; use any other external assistance unavailable to other participants is also prohibited

19. I will put all the promotional materials provided by the Organizer on my yacht as recommended: MKS 1 (Single) or MKS 2 (Double) flag on backstay, start numbers on sides or deckhouses, 20% of length from bow.
20. I will inform the Jury Committee via VHF, telephone or personally when I have crossed the finish line of long race (GPS time).
21. Advertising – I will not be carrying out any promotional activities at the event without the consent of the Organizer
22. I agree to have my image recorded, including the use of the photographs, recordings on any media, publication, public performance, display – against paying or for free and recording and duplication by any technique, sale of the original and copies. I waive any rights to any claims (present and future), including the right to any fee from the Organizer and any other entities participating in the organization of the event for the use of my image/voice/statements made to satisfy the requirements stipulated in the declaration.
23. I grant to the Organizer a non-exclusive licence, not limited in time or territory to use the photographs and materials submitted by me for the purposes of the event, with the right to duplicate, modify and disseminate them by any technique for the purposes of the event, including its organization and promotion, and I waive any fee that I might be entitled to in relation with the above.
24. I acknowledge that: the data is administered by Sailing Foundation Sailportal.pl; the data will be processed pursuant to the personal data protection act of 29 August 1997 (consolidated text in Dz. U. No 101/2002, item 926 as amended) by the administrator for the purposes related to the organization of Event. I have the right to access and update my personal data. I will not transfer my personal data to any other entity for purposes other than organization and promotion of the event. I have provided my personal data without any coercion, voluntarily and failure to provide my personal data to the Organizer makes my participation in the event impossible
25. I consent to the processing of data (e-mail) for marketing purposes by Sailportal.pl, and to receive from Sailportal.pl commercial information electronically in accordance with the Act of 18.07.2002. (Journal of Laws No. 144, poz.1204 as amended. d.) on electronic services
26. I acknowledge that my statement of non-compliance identified the actual situation: you may be excluded from the list of participants: (inadequate equipment, poor technical condition of the yacht, yacht obsolete documents, lack of licenses, poor health, undeclared advertising, other)
